IMA: completion of acquisition of a stake in MAI S.A.

The IMA Group strengthens its range of products in the machinery sector for the packaging of tea and herbs in filter bags

IMA finalised with Mr. Guillermo MAI the acquisition of a 70% stake in **MAI S.A.** located in Mar del Plata, Argentine, a company that manufactures and markets **machines for the packaging of tea and herbs in filter bags**, as announced on 28 December 2016.

IMA's overall outlay amounts to around 7.7 million USD, of which 5.7 million USD paid at the closing and the rest being due in three annual tranches.

IMA will also be granted an option, exercisable in April 2021, to buy 100% of **MAI S.A.**

In 2016 the MAI S.A. tea packaging business is expected to have sales of around 7 million USD and an EBITDA of approximately 1.5 million USD, with good growth prospects thanks to the overall support that the IMA Group can provide by integrating it with the rest of the Group.

For the completion of the transaction, IMA was advised by Pistrelli, Henry Marin y Asociados S.R.L., EY Buenos Aires and Studio Poggi & Associati of Bologna.

Established in 1961, IMA is world leader in the design and manufacture of automatic machines for the processing and packaging of pharmaceuticals, cosmetics, food, tea and coffee. The Group has more than 5,000 employees, more than 2,600 of whom overseas, and can count on 38 production plants in Italy, Germany, France, Switzerland, Spain, the United Kingdom, the United States, India, Malaysia and China. IMA has an extensive sales network comprising 29 branches which provide sales and service in Italy, France, Switzerland, the United Kingdom, Germany, Austria, Spain, Poland, Israel, Russia, the United States, India, China, Malaysia, Thailand and Brazil, representative offices in Central and East European countries and over 50 agencies covering a total of about 80 countries. **IMA S.p.A. has been listed on the Milan Stock Exchange since 1995 and in 2001 joined the STAR segment.** The following manufacturing companies are part of the IMA Group: Benhil GmbH, Co.ma.di.s.
