**With 784 million in June, total net inflows reach 5.66 billion euro.  
Managed assets inflows YTD at 3.09 billion, +43% compared to 2023.**

Banca Mediolanum S.p.A. announces the business results for **June 2024: € 1.04 billion**, of which:

- Total net inflows: **€ 784 million, € 5.66 billion YTD**
- Net inflows into managed assets: **€ 680 million, € 3.09 billion YTD**
- Loans granted: **€ 236 million, € 1.25 billion YTD**
- General insurance premiums: **€ 18 million, € 93 million YTD**

Massimo Doris, CEO of Banca Mediolanum, commented: “The solid positive trend continues with the added contribution from June, which allows us to close an exceptional first half with about 5.7 billion of total net inflows and 3.1 billion of net inflows into managed assets products. June stands out as the best month of the year for managed assets flows, with 680 million, mainly headed towards in-house products. Customer acquisition is also progressing well, with 109,000 new customers in the year, 10% more than in 2023”.

Doris continues: “This first half of the year has ended splendidly and we have been a main player also thanks to the promotional initiatives dedicated to customers aimed at boosting organic growth of the Group even more. This is a great foundation Family Bankers can build on, offering the high-quality advice that has always been our distinctive feature”.
