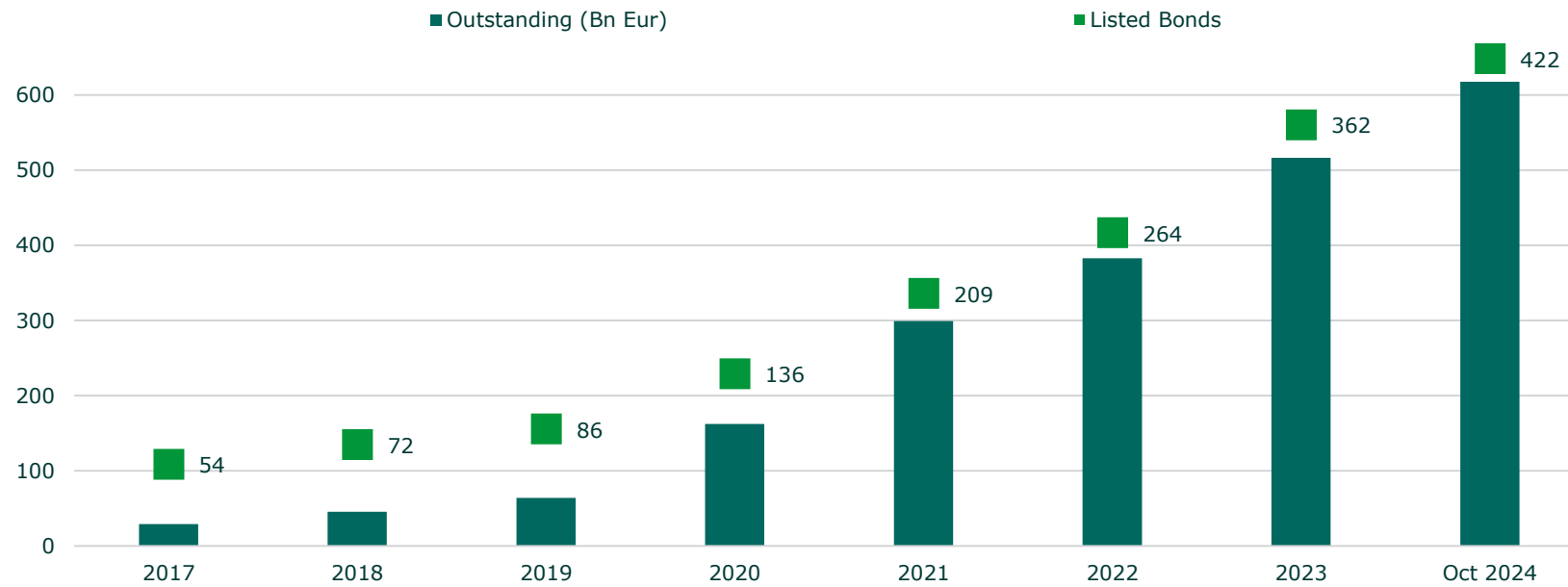

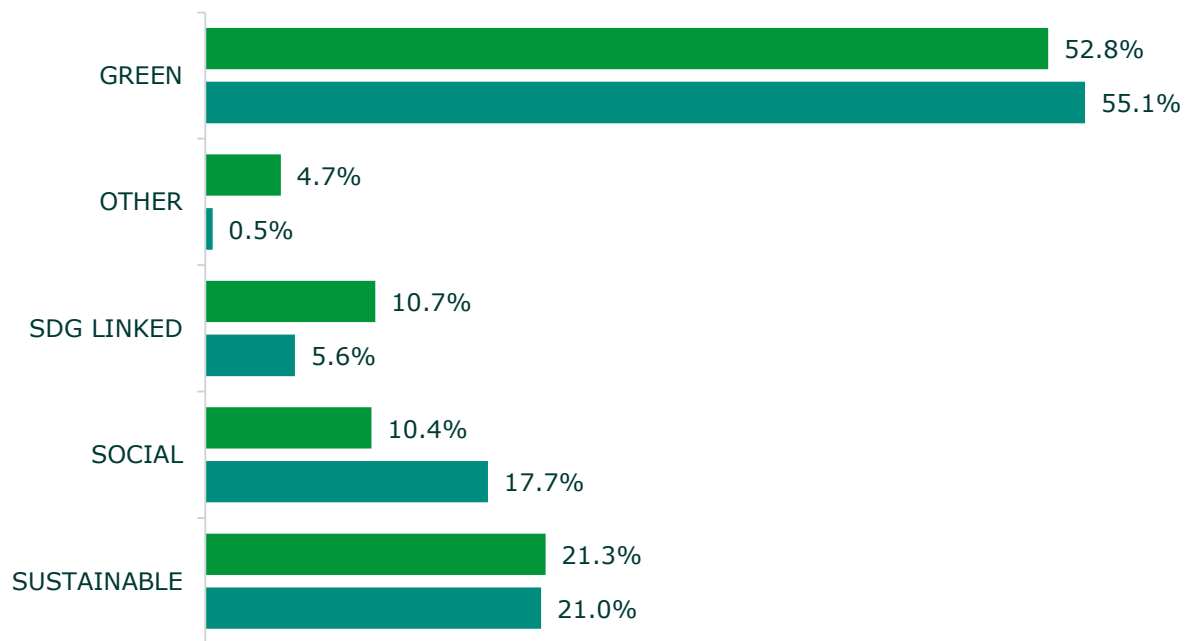

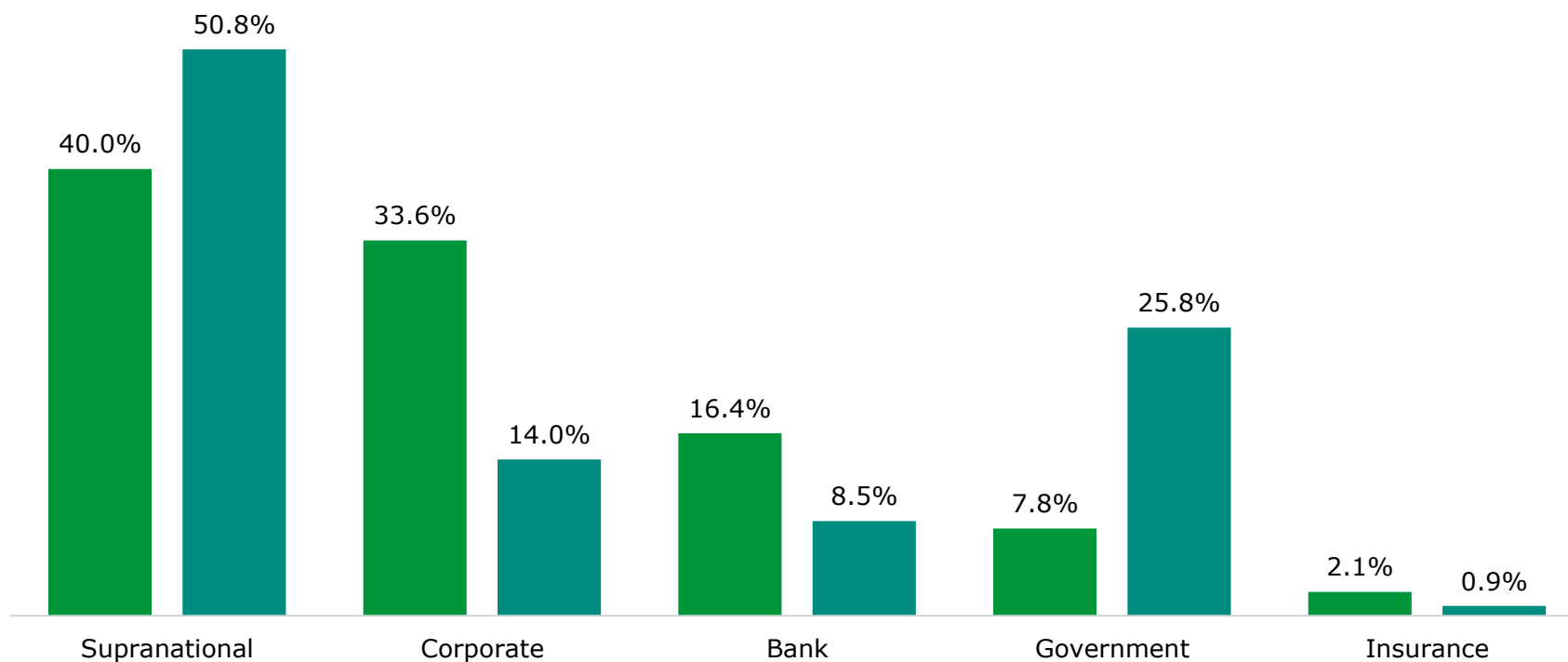

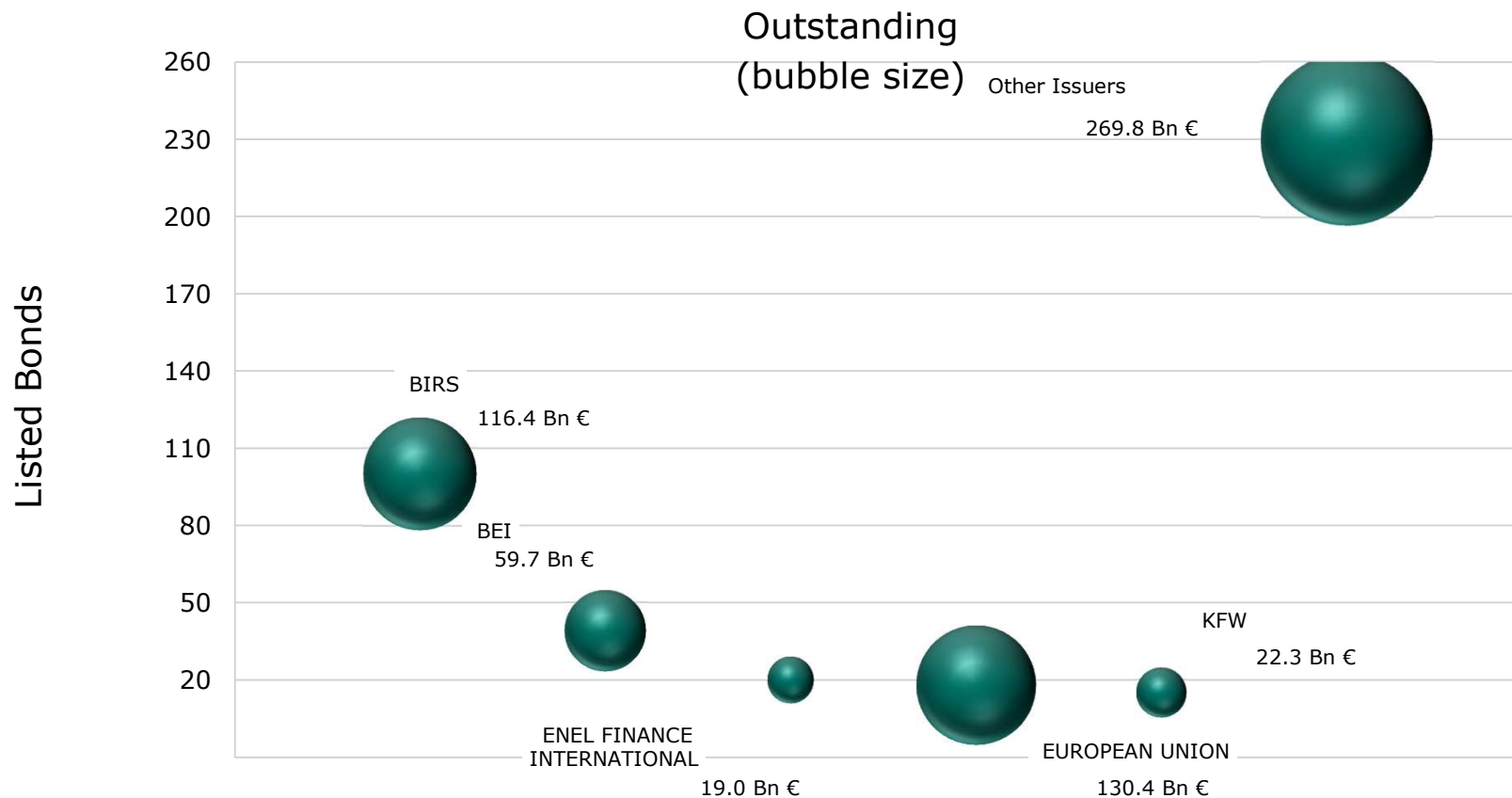

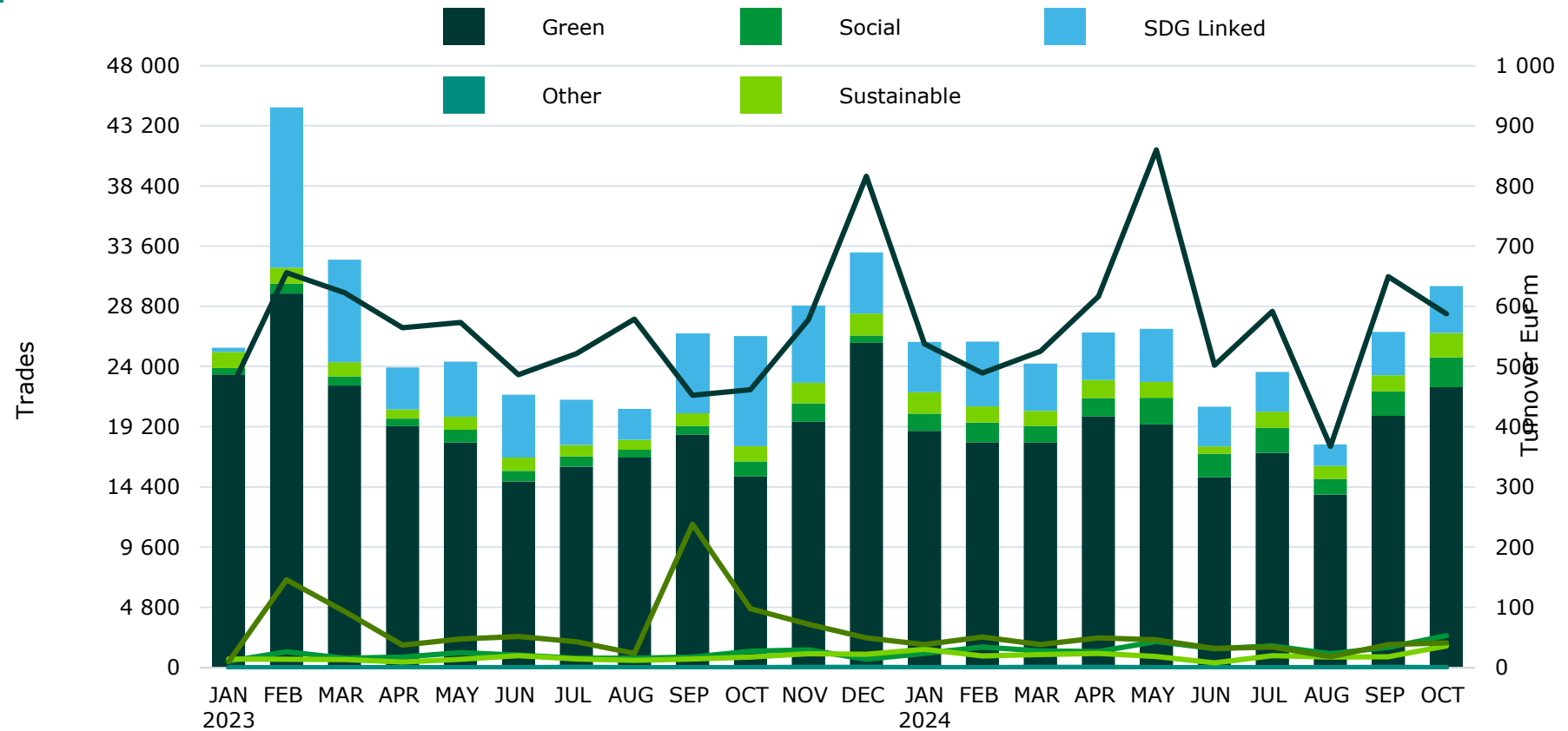

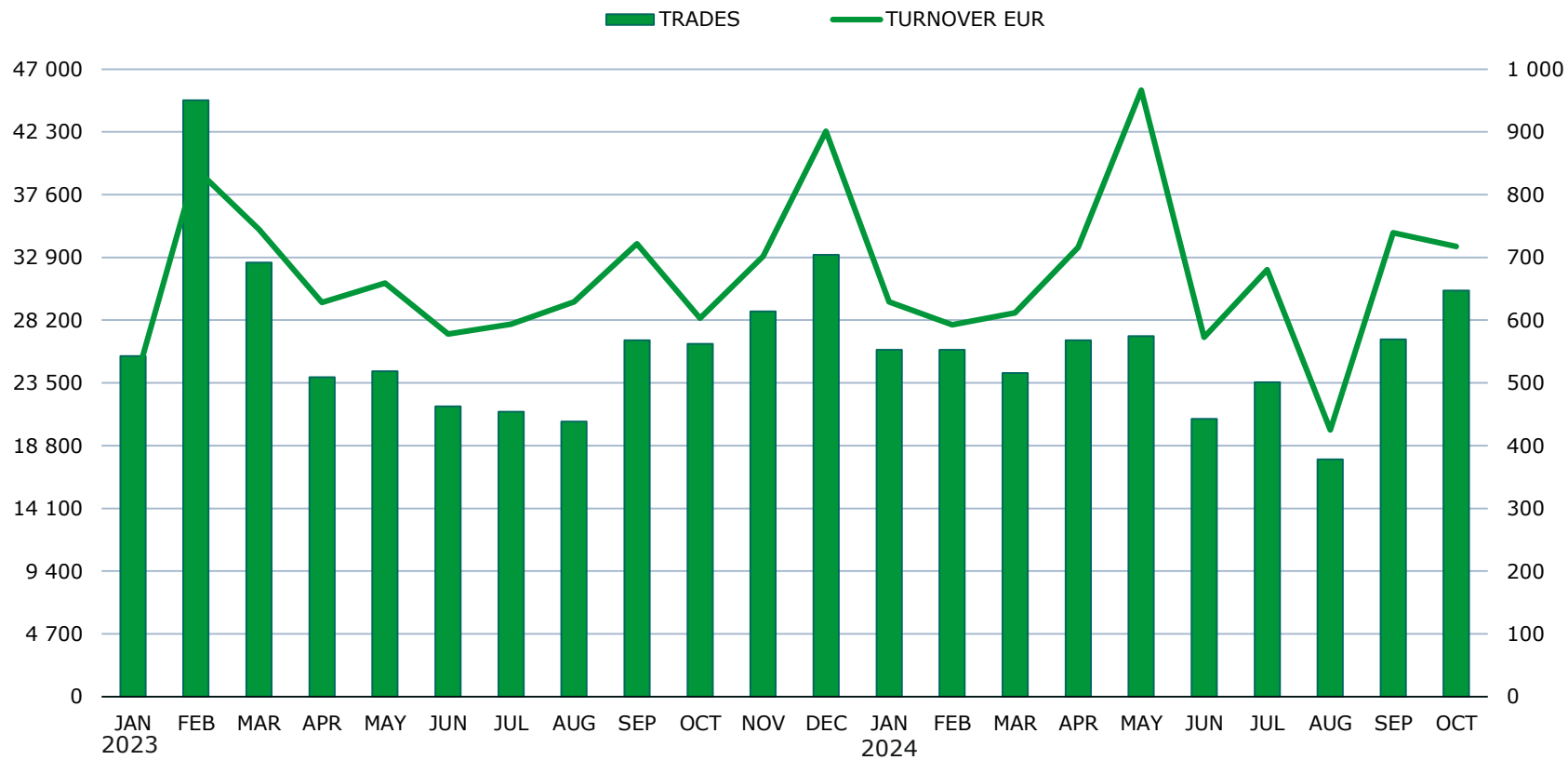

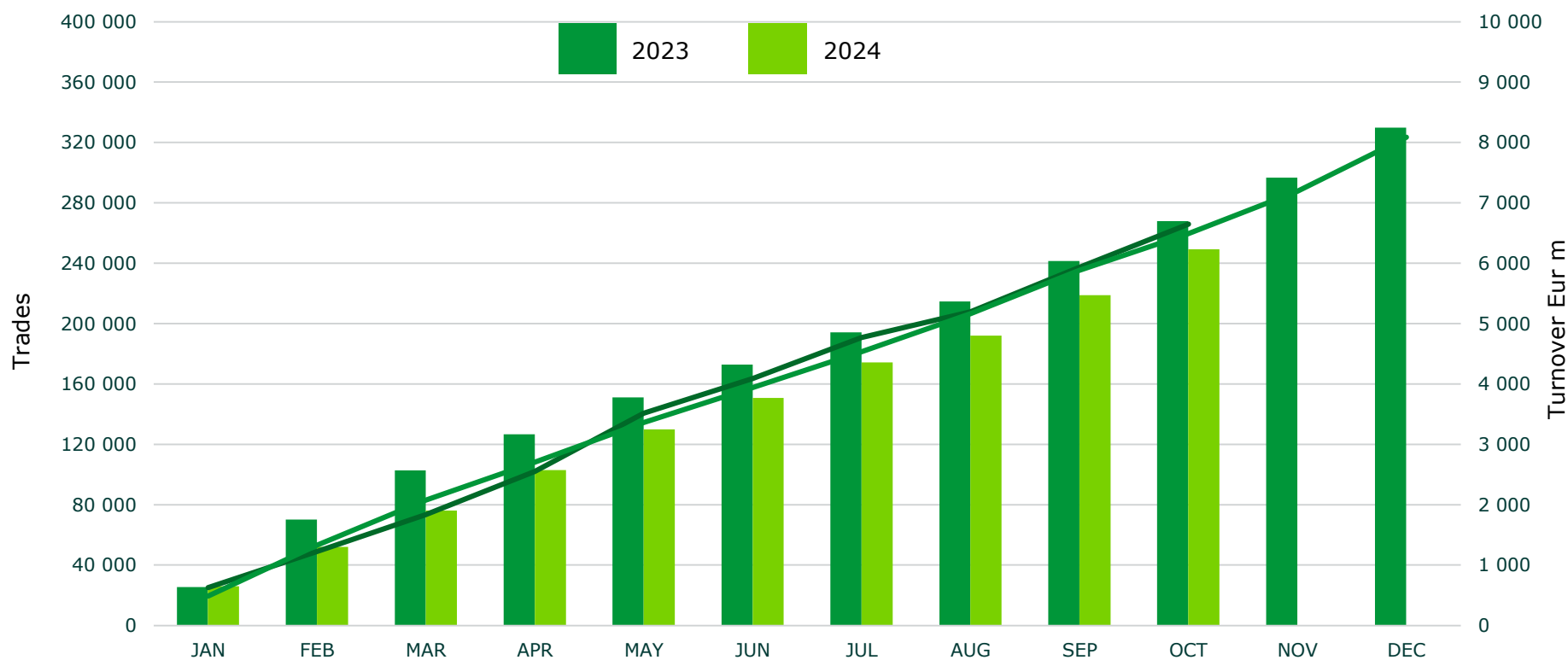
# ESG Bonds – Trading Evolution
